The presentation of the legal framework of the production process of agricultural products and food as a mixed field of law by analyzing the underlying national and EU legislation and the personal, activity and organizational factors of structural and agricultural market policies and agro-ecological minimum standards that reflect the leading requirement of food security. The most important current tendency in agricultural law is "greening", which is also connected with the aims of Food law, especially providing "healthy" food while conserving the environmental media as the natural bases of life. The course studies the principles and norms of these cross-lying fields of law.

The natural environment of farming II .: Land and soil protection.

11. week

The natural environment of farming III .: Nature conservation, habitat protection.

The principles of land registration, the legal effects of the registration.

The land registration process and authorities. The registration of land use.

The final links of the food chain: market policy, the agricultural market regulation, the common organisation of the markets in agricultural products. The protection of consumers' interests. Agricultural contracts.
