SZÁMONKÉRÉSI ÉS ÉRTÉKELÉSI RENDSZERE / ASSESSMENT'S METHOD**The conditions of the signature:**

- participation on at least six from eight roll calls, in proportional distribution during the semester.

The way of appraisal:

- 1) Participation on at least six from eight roll calls, in proportional distribution during the semester.
- 2) Two midterm tests during the semester, with a test paper of 30 points of each. A missed midterm test cannot be filled.
The point limits are as follows: 0-15 unsatisfactory, 16-19 satisfactory, 20-23 average, 24-27 good, 28-30 excellent.
In case a student does not write any of the tests, or the result of any of the tests does not reach 16 points, then he/she shall fill it in the first week of the examination period.
- 3) After the first midterm test, students shall give a presentation on a chosen subject or shall write an essay. These tasks can be fulfilled individually or in groups of 2-3 members.

The requirements of the oral presentation are as follows:

- a thorough working up of the chosen subject,
- an exposition of the results on the lesson in front of the teacher and the fellow students,
- the length of the presentation: 15-20 minutes,
- the students may apply a ppt performance according to his/her choice,
- the task can be fulfilled individually or in groups of 2-3 members. In the latter case, the chosen subject shall be divided into parts and every member shall give an oral presentation on his/her part.

The formal requirements of the essay are as follows:

- the extent of the essay is: minimum 8 - maximum 12 typed pages,
- A/4 paper size,
- typed on two pages, one and a half spacing,
- Times New Roman type of letter, font size of 12 points,
- margins: left-right-bottom-top 2,5-2,5 cms,
- page numbering: in the middle of the bottom, within the margin.

Based on fulfilment of the 3 conditions, the semester is finished with a mark of 5 grades.
