OKTATÁS CÉLJA / AIM OF THE COURSE

Aim of the course:

To gain understanding of the basic concepts and principals of international trade - through acquiring a relatively wide range of different knowledges that are connected. Students will learn all basic elements (trade techniques) - the main components of the foreign trade processes and procedures that are relatively very complex – from preparation/establishment (market research, bidding, contracting) to transaction (transit procedures, methods of payment, etc.). Finally, this course gives participants the basic skills required to handle all the aspects of exports and imports.
